2024 POOL RULES

The Green Level Crossing Community Association assumes no liability of risk for injuries, deaths, loss, or damage to any personal property of anyone using the recreation facility.

1. Swim at your own risk.
2. No one should swim alone for their own safety.
3. An assigned key fob by a homeowner is required for entrance to the pool area. Entrance is only permitted during posted hours of operation. All other access is trespassing.
4. Wake County requires that all pool gates be kept closed. All members are required to ensure that the gates to the pool area are closed when entering or exiting. *
5. No children under the **age of 14** are permitted in the pool without a responsible guardian present.
6. Guests shall not exceed 4 guests per household and must always be accompanied by a homeowner while at the facility.
7. Individuals who are incontinent must wear appropriate swim diapers. If an accident occurs (vomit or defecation), everyone must exit the pool immediately. The pool will remain closed for a minimum of 24 hours after the management company has chemically treated the pool. *
8. Proper swim attire is required. No cut-offs, torn tee shirts, street clothing or thongs are authorized.
9. All individuals using the pool should shower before entering the pool.
10. No glass allowed in the pool or on the deck*. If broken glass is found, the pool may need to be drained.
11. No running.
12. No diving.
13. No person under the influence of alcohol or drugs may use the pool.
14. No smoking or vaping of any kind or chewing of tobacco.
15. No person with skin, eye, ear, or nasal infection(s) is allowed in the pool.
16. No person with a communicable disease is allowed in the pool.
17. No animals or pets are allowed within the pool area (except registered service dogs).
18. No eating or drinking inside pool or within 6 feet of the pool.
19. No skateboards, roller blades, scooters, bikes, etc. on the pool deck.

20. No profanity, horseplay, harassment, or abusive behavior.
21. If you bring food or beverage items, you are responsible for cleaning up any spills before you leave. Please use the containers provided for trash.
22. A first aid kit and emergency telephone are located on the entrance wall.
23. Furniture and equipment are not to be removed. Chairs should always remain upright and out of the pool.
24. Safety equipment is for emergency purposes and should not be handled or removed at any other time.
25. If a "Pool Closed" sign is posted, no entry to the pool area is permitted.
26. The pool slide is not operational when lifeguards are not present. Follow all posted signs and any direction from lifeguards or staff for use of the slide.
27. All persons using this pool do so at their own risk. Owners and Management are not responsible for accidents or injuries.
28. Lap swim is permitted from 6:00 am until 9:00 am, with annual preregistration waivers on file.
29. Only the following flotation devices are permitted in the pool: devices approved by the U.S. Coast Guard (all approved devices have a specific product label that states whether the device is U.S. Coast Guard approved), pool noodles, kickboards, and tubes. The pool manager has discretion to disallow flotation devices when the pool is crowded.
30. One-on-one private lessons are permitted in the pool on Mondays through Thursdays from 10:00 am to 2:00 pm. Instructors must fill out annual indemnity forms.
31. Only toys designed for pool use are permitted inside the pool. The pool manager has discretion to disallow toys when the pool is crowded. Tennis balls, footballs, and other athletic balls are not permitted in the pool.

*Marks a mandatory Wake County Statute Pool Rule. Violation of these rules can result in the County closing the pool.

The Association may suspend the right to use certain or all the common areas by an owner for infractions of its published rules and regulations for up to 60 days per infraction (this includes any violation that has been communicated to the lot owner).
